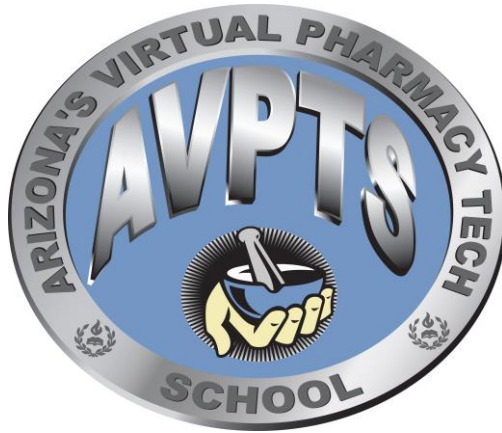

What are Health and Safety Requirements?	A person seeking employment, licensing, or admittance into college, university or educational program may be required to apply for a <u>Fingerprint Clearance Card</u> . A successful applicant will receive a small laminated card verifying that the person is capable of gaining legal employment based on his or her criminal background. Some hospitals or pharmacy sites have <u>Health and Safety</u> requirements and may require immunization, drug screening, or the release of medical records prior to attending the externship.

Externship/Practicum

The pharmacy externship helps students transition from the online (or virtual learning) class room to the clinical practice which is a crucial step in becoming a pharmacy technician. Under the guidance of a licensed pharmacist students will learn how to fill, process, and compound medications. Most students will complete their externship at [Walgreens](#) or [Pillpack](#) or another retail pharmacy where they are given the opportunity to showcase their online knowledge to the real world environment. This experience may lead to gainful employment.

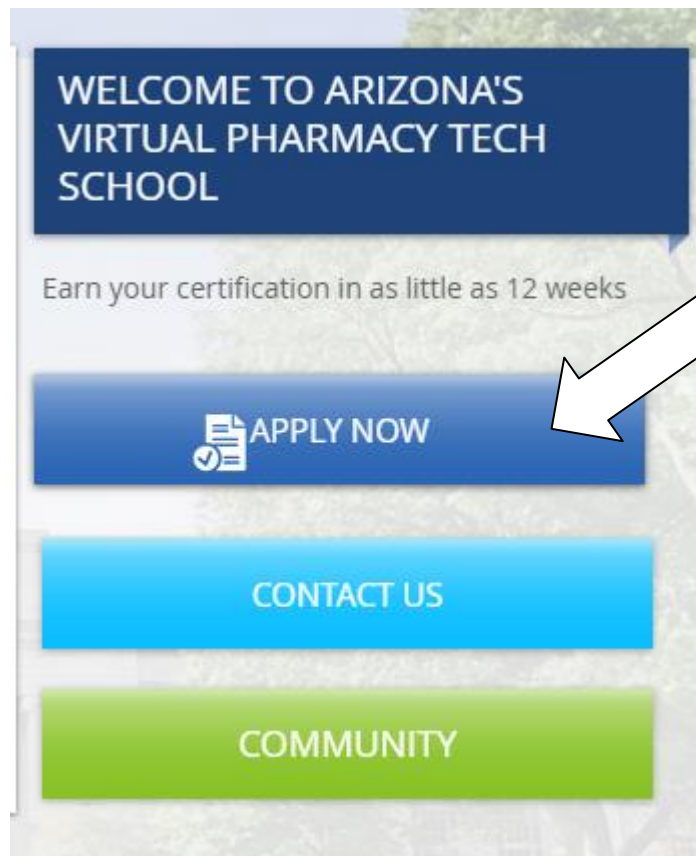
